COLETTA BARRETT, RN, FACHE

Coletta Barrett serves as Vice President of Mission for Our Lady of the Lake Regional Medical Center – a tertiary, Catholic Academic Medical Center in Baton Rouge, La. Coletta serves as the senior

leader responsible for the interpretation, clarification, and integration of the Franciscan charism into daily operations of the Baton Rouge region for the Franciscan Missionaries of Our Lady Health System. She is operationally responsible for the development and administration of Community Advocacy, Community Impact and Community Benefit.

She currently serves as the Chairman of the Board for the Mayor's Healthy City Initiative in Baton Rouge. Charged with improving the city's outcome measures for health, she leads an 104 member coalition of community stakeholders. In 2015 The Mayor's Healthy City Initiative was awarded the 2015 NOVA Award from the American Hospital Association for being the only community in the United States to achieve a Joint Community Health Needs Assessment and a Joint Implementation Plan among multiple competing hospitals. During COVID-19 Medical leaders from the hospital coalition meet daily, weekly and now monthly to address community health testing, vaccination and healthcare delivery needs.

Coletta is a Registered Nurse, achieved a Master's of Health Administration from Tulane School of Public Health and Tropical Medicine and is a Fellow in the American College of Healthcare Executives and currently a Doctorate in Nursing Practice student at Southeastern Louisiana University.



CYNTHIA BIENEMY, PHD, RN

Dr. Cynthia Bienemy has been a registered nurse for over 39 years. Her experience includes nursing practice, nursing education at the undergraduate and graduate levels, nursing

research, project planning, funding, and program evaluation. Dr. Bienemy received her Bachelor of Science Degree in Nursing from Southeastern Louisiana University in 1981, a master's degree in Cardiovascular Adult Health Nursing in 1993 from McNeese State University, and a PhD in Nursing from Southern University and Agricultural and Mechanical College in 2004. Dr. Bienemy has served as the Director of the Louisiana State Board of Nursing-Center for Nursing since 2009. In this role, she is charged with collecting, analyzing, and reporting on the registered nurse (RN) and advanced practice registered nurse (APRN) workforce. Dr. Bienemy addresses issues related to nursing education capacity, nurse supply, and nurse demand and in 2013 she worked with out of state consultants to create Louisiana's first statewide multiregional nurse supply and demand forecast model which was funded by the Louisiana State Board of Nursing and the Louisiana Health Works

Commission. She has served as the co-lead for the Louisiana Action Coalition (LAC) since its inception in 2011 and chairs LAC's Diversity Steering Committee which focuses on increasing the diversity of Louisiana's RN and APRN workforce. Dr. Bienemy has also served as lead for LAC's Culture of Health Summit Planning committee for the last four years. Dr. Bienemy has served as the President, Immediate Past-President and Board member for the National Forum of State Nursing Workforce Centers, President of the Tau Pi Chapter of the Sigma Theta Tau International Honor Society of Nursing and Chair of the Louisiana Health Works Commission. Dr. Bienemy is the current Chair of Louisiana's Nursing Supply and Demand Council and recently ended a four year tenure as a member of the National Advisory Council for Nursing Education and Practice which advises the Secretary of the U.S. Department of Health and Human Services and the U.S. Congress on policy issues related to Title VIII programs. Dr. Bienemy is an American Nurses Association Substance Abuse and Mental Health Services Administration Ethnic Minority Fellow Alumnus and was a 2018 Louisiana Nurses Foundation Nightingale Hall of Fame Inductee. Prior to becoming the first Director of the Louisiana Center for Nursing, Dr. Bienemy was an Associate Professor in the Graduate Nursing Program at Southern University and A & M College.



DENISE BOTTCHER

Denise Bottcher is the State Director of AARP Louisiana and is responsible for advancing the organization's social mission on behalf of Louisianans 50-plus and their families. With nearly

500,000 members and 22 volunteer leaders across the state, Denise leads the five-member team in Baton Rouge and New Orleans to help all generations live their best lives in their own homes and communities through advocacy, education and service.

Through her strategic guidance and leadership, Denise and her team have driven social change at the state and local level by working with policy makers, collaborative organizations, and dynamic volunteers. Family caregiving, health care, financial resilience, and livable communities are her top priorities.

She holds an appointment in the School of Graduate Studies at LSU Health New Orleans and also serves as a Nurse Researcher at Children's Hospital New Orleans. She is currently the recipient of the Sister Henrietta Guyot Endowed Professorship in Nursing. Dr. Chatmon is a certified nurse educator, as well as a certified Adult and Youth Mental Health First Aid Instructor. In addition, Dr. Chatmon is an evaluator for Commission on Collegiate Nursing Education (CCNE). She has demonstrated exemplary contributions to the profession of nursing through service and mentoring and her commitment to her university community as well as the general public. She was recently accepted into the Health Equity and Anti-Racism (HEAR) Leadership Institute. She has served as the Director of membership, recruitment, and retention for Louisiana State Nurses Association (LSNA) and now serves as President-Elect for LSNA. Dr. Chatmon also serves as a member of the LAC, the Board of Trustee for Louisiana Nurses Foundation, and the Board of Trustee for CrescentCare. She is also the President of Epsilon Nu Chapter of Sigma Theta Tau International.



Dr. Chatmon is an active member of Delta Sigma Theta Sorority Incorporated and serves as Chapter President for River Parishes Alumnae Chapter. Notably, Dr. Chatmon is also a veteran in the United States Army.

In this role, she served as a key member of the leadership team for the report, The Future of Nursing 2020-2030: Charting a Path to Achieve Health Equity, released in May 2021. In partnership with AARP, she directs the Foundation's Future of Nursing: Campaign for Action. This national initiative is transforming health and health care through nursing, and building a healthier America.

Hassmiller has worked in public health settings at the local, state and national levels, including the Health Resources and Services Administration. She taught community health nursing at the University of Nebraska and George Mason University.

Hassmiller is an elected member of the National Academy of Medicine, a fellow in the American Academy of Nursing. She also sits on other advisory committees and boards, including the Hackensack Meridian Health System, UnitedHealth, Carrier Clinic, NursesEverywhere, and the American Red Cross. She is the recipient of many awards and four honorary doctorates, but most notably the Florence Nightingale Medal, the highest international honor given to a nurse by the International Committee of the Red Cross.



LISA HAWTHORNE, PHD, MSN, RN, PHN, CNE

Dr. Lisa Hawthorne is the Director of Nursing & Chief Nursing Administrator for the Associate Degree Nursing program at Louisiana State University (LSU) in Eunice, Louisiana. She began

her career as an associate degree nursing graduate of Arizona Western College in Yuma, AZ and began her nursing practice in orthopedics in San Diego, CA. She found her passion in nursing working in community health, and eventually in faculty & leadership roles in nursing academia. She holds certification as a Certified Nurse Educator and Public Health Nurse. Dr. Hawthorne earned her PhD in Nursing through the Hahn School of Nursing at the University of San Diego, where her dissertation research was based on the success of licensed practical/vocational nurses in pursuit of earning an associate degree in nursing.

In addition to Dr. Hawthorne's role at LSU, she is an advocate for online learning to advance the opportunity for educational pursuits regardless of where nurses live. She currently serves as core faculty with American College of Education for the EdD and EdS programs, with an emphasis in nursing. She serves as a director for the Louisiana League for Nursing, and state Co-Lead for Louisiana Action Coalition to advance the Future of Nursing 2020-2030 recommendations. Dr. Hawthorne is a member of the Texas League for Nursing, Louisiana Nurses Association, Sigma, National League for Nursing, and Organization for Associate Degree Nursing.



KIMBERLY HOOD, JD, MPH

Kimberly L. Hood is the Assistant Secretary for the Office of Public Health at the Louisiana Department of Health. She is an attorneyturned-public health professional who has held leadership roles in non-profits and a federally qualified health center with a focus on the prevention, diagnosis and treatment of infectious disease in the primary care setting. Kim received her JD from Louisiana State University in 1998 and her MPH from the University of North Carolina at Chapel Hill in 2013. She joined the team at the Louisiana Department of Health as the Hepatitis C Elimination Project Manager in 2018 and was involved in the State's COVID-19 response efforts until transitioning into the role of Assistant Secretary in early 2021.



TONYA JAGNEAUX, MD, MSHI, FCCP

Dr. Jagneaux is currently the chief medical informatics officer at Our Lady of the Lake Regional Medical Center in Baton Rouge, LA. She is an Associate Professor of Clinical Medicine

in the specialty of pulmonary/critical care at Louisiana State University Health Sciences Center in New Orleans, LA. She is also an Adjunct Associate Professor in the LSU College of Engineering. She earned her Master's of Science in Health Informatics in 2016 from Northwestern University and she currently practices and teaches medicine at the LSU Health Sciences Center in Baton Rouge, LA. Her interests and research include addressing social determinants of health in medicine, early diagnostics in sepsis care, patient safety & quality in hospitalized patients and medical information science.



CHARLA B. JOHNSON, DNP, RN-BC, ONC

Dr. Charla Johnson is the system director of nursing informatics with Franciscan Missionaries of Our Lady Health System. The health system has seven hospitals across Louisiana and in

Mississippi. Dr. Johnson's nursing career for the health system has spanned more than three decades serving in a variety of roles supporting acute care nursing. In her current role as system director of nursing informatics, she is responsible for regulatory components associated with promoting interoperability of the electronic health record and ensuring the systemness integration of evidence-based practice in nursing documentation within the electronic medical record. Her specialty in nursing began in the field of orthopedics where she continues to work at the national level and within communities to reduce musculoskeletal healthcare disparities. She is certified in orthopaedic nursing and nursing informatics. Dr. Johnson is the current president of the National Association of Orthopaedic Nurses and is an instructor for Franciscan Missionaries of Our Lady University in Baton Rouge, Louisiana, where she teaches a graduate-level research methods course.



KAREN C. LYON, PHD, MBA, APRN-CNS, NEA

Dr. Karen Lyon is currently Chief Executive Officer and Appointing Authority of the Louisiana State Board of Nursing (LSBN) where she has regulatory oversight for 71,468 RNs, 8,280 of whom are

APRNs. Louisiana is also the only state in the nation which regulates pre-licensure students' admission to clinical nursing courses, and Dr. Lyon has regulatory oversight over 12 associate degree programs, 14 baccalaureate programs, 1 diploma program and 12 graduate nursing programs offering APRN degrees or post-graduate certificates.

In her 8-year tenure in Louisiana, she has collaborated with the Louisiana Medical Board on joint APRN rules related to collaborative practice agreements and she has overseen policy changes in LSBN rules allowing for APRN disaster permits, CRNA provision of ancillary services within their scope of practice, medication delegation to certified medication attendants under direct supervision of RNs and APRNs, revision of the entire chapter on nursing education program development, and regulation and revision of section 3331 related to discipline, delay and denial of nurses and nursing students based on specific misdemeanors and felonies. In 2018, she coordinated the efforts of LSBN with Senator Barrow Peacock to pass SB 202 enacted as Act 577 establishing Louisiana as the 31st state to become a member of the Nurse Licensure Compact. During 2020 and 2021, she has worked with the Governor's Office and the Louisiana Department of Health to coordinate emergency rules and nursing regulatory changes to manage professional nursing's response to the COVID-19 pandemic. Dr. Lyon was elected in August 2021 to the National Council of State Boards of Nursing's (NCSBN) Board of Directors. She has also been appointed to represent the NCSBN Board as liaison to the NCLEX® Examination Committee and will be an inaugural graduate of NCSBN's International Center for Regulatory Excellence Advanced Leadership Institute.



DEMETRIUS J. PORCHE, DNS, PHD, PCC, ANEF, FACHE, FAANP, FAAN

Dr. Demetrius James Porche is Professor and Dean of Louisiana State University Health Sciences Center in New Orleans, Louisiana School of

Nursing. He is currently serving as Interim Vice Chancellor for Academic Affairs. He holds an appointment also in the School of Public Health at Louisiana State University Health Sciences Center. He received his undergraduate Bachelor of Science in Nursing degree from Nicholls State University and his Master of Nursing and Doctor of Nursing Science from Louisiana State University Medical Center. He completed Family Nurse Practitioner post-graduate coursework at Concordia University Wisconsin. Dr. Porche earned a Doctorate of Philosophy from Capella University in Organization and Management with a specialization in Leadership.

Dr. Porche is certified as a Clinical Specialist in Community Health Nursing and Family Nurse Practitioner. Dr. Porche was the Associate Editor of the Journal of the Association of Nurses in AIDS for 10 years. He is currently the Chief Editor of American Journal of Men's Health. Dr. Porche served on the Editorial Board of The Journal for Nurse Practitioners. He served as president of the President of the American Assembly for Men in Nursing for two terms.

Dr. Porche served on the Louisiana State Board of Nursing. Dr. Porche has Chaired the Louisiana State Nurses Association Continuing Education Committee. He served at the national level on the Governing Council of the American Public Health

Association and served as Chair of the Public Health Nursing Section Development Committee. Dr. Porche has served on the Research Committee of the Association of Community Health Nurse Educators, Education Committee of the National Association of Clinical Nurse Specialists, and Doctoral Conference Planning Committee of the American Association of Colleges of Nursing, and served two terms as Treasurer and President of the Southern Nursing Research Society. He is a Virginia Henderson Fellow of Sigma Theta Tau International and a Fellow in Society of Luther Christman Fellows for Contributions to Nursing by Men. He has served as a national mentor in the Sigma Theta Tau International Chiron mentoring program and the American Association of Colleges of Nursing Dean Mentor Program. Dr. Porche was inducted as a fellow in the American Academy of Nurse Practitioners, Fellow in the American Academy of Nursing, Fellow of the American College of Health Care Executives and Fellow of the American Academy of Nurse Educators. He currently serves on the American Association of Colleges of Nursing Board, Chair of the Louisiana Health Works Commission, and Chair of the Louisiana Council of Administrators in Nursing Education.



ECOEE ROONEY, DNP, RN, AFN-C, NPD-BC, SANE-A, DFN-AFN

A distinguished leader, Dr. Rooney has more than 20 years of nursing experience and is a recognized forensic nursing and nursing leadership expert.

She is the director of nursing leadership development for Ochsner Health and the President of the Louisiana State Nurses Association.

Rooney is sought out for her expertise in leadership, healthy work environments, mitigating compassion fatigue, and vulnerable populations. In addition, she has presented workshops on recovering from conflict and trauma for international participants in the International Visitor Leadership Program through the U.S. Department of State and the New Orleans Citizens Diplomacy Council, in New Orleans, LA.

An active member in national and regional professional nursing organizations. Rooney is a past president of the New Orleans District Nurses Association, past Chair of the awards committee for the International Association of Forensic Nurses



and has served on task forces and committees of various professional nursing organizations, locally and nationally.
